1. ShowPro agrees to provide high quality sound equipment, recorded music, Disc Jockey (and/or Celebrant and/or MC by agreement) entertainment and lighting equipment at event address at the times listed.
2. In the event of any unforeseen circumstances such as death, serious illness or injury to the DJ, unexpected mechanical delays or failures, or acts of nature, the Contractor agrees that all efforts will be made to secure another appropriate DJ/MC or equipment for the night. If for any reason this is not possible the Contractor's deposit and balance paid to date shall be refunded in full by ShowPro.
3. Subject to clause 2, ShowPro guarantees that the DJ on the night will be Richard Mills personally.
4. Should Contractors cancel this event SHOWPRO will retain deposit as liquidated damages unless the date can be rebooked for at least the same total fee. Any cancellation after the deposit has been made must be in writing or email.
5. Should Contractors postpone this event for any reason less than 4 weeks from function date, ShowPro will retain payments made as liquidated damages unless the date can be rebooked for at least the same total fee. Accommodation will be made whenever possible to reschedule cancelled or postponed events but are subject to availability and receipt of a further advance payment.
6. For outdoor performances, Contractors shall provide side and overhead shelter for set-up area. Should ShowPro be forced to terminate performance after commencement due to weather that cannot be protected by Contractor's provided shelter, total performance fee is due.
7. Contractor ensures venue has all appropriate amplified music licensing and performance permits.
8. Contractor approves of website publication of tasteful images taken by ShowPro during the day. Any images that are not to be published should be advised to ShowPro and they will not be published, or in the instance where they have been published, they will be removed by ShowPro.
9. Contractor agrees to ensure the safety/security of the performance area and allows ShowPro the option to terminate performance if Contractor, their agents or guests interfere, impede, or constitute a nuisance to ShowPro where the integrity, quality, or safety of ShowPro equipment and/or performance shall become detrimentally affected. In this event, Contractors shall pay the total performance fee regardless of the length of performance.
10. Contractor accepts full financial responsibility during the time of performance for loss or damage to ShowPro sound, lighting or personal property and equipment that is caused by themselves, their contractors, agents or guests at the event.
11. ShowPro is not responsible for power failure or power outages. If such event occurs, total performance fee is required. ShowPro will do their best to keep your guests entertained until the power comes back on, or until contracted time expires.
12. In the event of a dispute, both parties shall agree upon a payment or refund amount. If not resolved, Contractor agrees such matter will be acted upon subject to the laws of the City of Wellington, New Zealand. If legal advice is sought to protect the rights of ShowPro, losing party will pay the legal fees for both parties, plus all court costs, if any.
13. If Contractor does not pay the bill by the due date for payment, the Contractor will pay any costs incurred in recovering the money owed.
14. Approval of overtime is to be agreed between Contractor and ShowPro and is payable to ShowPro at event at the rate of \$100.00 (plus GST) per hour or part hour.
15. If Contractor selects music for the event that ShowPro does not have then Contractor can either supply ShowPro with their own copy, or ShowPro will purchase music where possible to a maximum value of \$40 and Contractor will be responsible for the remainder.
